United Way

Bridge funding of \$3,440 over five months has been approved.

Canada Post Community Grants

- Approved preparing a proposal, due April 5
- Potential projects:

 - Consider the growth of the Shelburne community –composed of young families, commuters

- Develop a stronger public message about the value of good parenting
- Utilize current research being done by Dufferin County as part of Service Delivery Modernization

Treasurer's Report

Phyllis reported having a bank balance of around \$32,000

- The bridge funding from United Way is welcome
- Can we increase Laura's hours?

 - *#* of hours necessary to reasonably complete her job function (given Board Members are not always able to volunteer more time and the increase in writing funding proposals, etc.);
 - *#* of hours she is able/willing to increase to meet the demand of her assessment

Fundraising

- Part of the condition of the UW bridge funding is to increase our own resources
- Perhaps workshops could be packaged and proposed for sponsorship by a service club and/or companies
- Workshop packages could be offered to companies as a connection to UW collaborate with the new Dufferin UW staff person

Promotion

- Snap'd Dufferin only publishes columns as part of an advertising package, which does not fit our needs
- Do some research into reaching and involving Dads, such as developing a family event that would be fun and engaging.
- Solicit ideas via social media perhaps with a prize or incentive, such as coupons to Little Caesar's
